Alvin Lasquety Sentin, our ordained clergy at **Luntiag Aghama Natural Divine Arts Shrine of Healing Inc.**, shall be appointed as the Chief Administrator or Punong Lakay that will minister Bahay Siadtala Binabaylan upon the incorporation of the said Ministerial Center.
